

WHY WE WALK...



Eleven housing agencies participate in this Walk and with the funds raised assist families throughout Cape Cod as wages earned here aren't enough to make ends meet. This Walk works because it is **founded in Love**, its member agencies are **Committed to the Mission**, and the **Collaboration is strengthened each year by walking together, and now by carrying forward Bob's life work.**

Barnstable County Statistics: The living wage shown below is the hourly rate that individuals must earn to support their family on Cape Cod, if they are the sole provider and are working full-time (2080 hours per year) and includes expenses for food, child care, medical, housing, transportation, and other expenses. The state minimum wage is the same for all individuals, regardless of how many dependents they may have. The poverty rate is typically quoted as gross annual income. We have converted it to an hourly wage for the sake of comparison.

For a Family of 2 Adults, 3 Children

Hourly Wages

Living Wage

\$24.46 x 2080 hours = \$50,877**

Poverty Wage

\$12.40 x 2080 hours = \$25,792

Minimum Wage

\$8.00 x 2080 hours = \$16,640
